**Subject: Regarding provisional No Objection Certificate (NOC) for starting of New Degree College with Science, Commerce and Arts Stream in the name of Sardar Ajit Singh College Kirmach (Kurukshetra) (Under Minority) on Self Financed Basis from the Session 2017-18.**


You are hereby permitted Provisionally to start new Degree College with Science, Commerce and Arts Stream under self-financing basis in the name of Sardar Ajit Singh College Kirmach district Kurukshetra (Under Minority) on the following terms & conditions:-

1. No financial assistance/grant in any form at any stage will be given by the State Government. The institution will have to bear all the recurring and non-recurring expenditure of the classes for all times to come. The building intended for educational occupancy will not be used for any other occupancy of any institutions/College.
2. The institution will follow to seek affiliation from the concerned affiliating University for the Courses (and send a copy to this office) and shall follow all other conditions imposed by the concerned affiliating University/University Grants Commission and State Government. However, minority educational institutions have a right of seeking affiliation with any affiliating body of their own choice.
3. The institution will follow all the guidelines of the University Grants Commission/concerned affiliating University and State Government in the matter of recruitment of staff and staff strength(under minority).
4. The institution will appoint qualified Assistant Professors in required number as per norms and submit report to this office to State Government. The institute shall also submit a detailed report regarding the number of students enrolled in the classes for which the Provisional NOC is issued after the commencement of the academic session.
5. Freedom to fix rational fee structure without any capitation fee or undue profit.
6. Full freedom in respect of admission of student belonging to the minority community. However, relative merit and transparency needs to be maintained even for admission of the students of that community. In case of aided/unaided minority institution, the admission of students from the community should be to a reasonable extent (say upto 50 %).
7. Right of non-taking over of management by Govt. in respect of the Minority Educational institution and no direction for any form of reservation may be imposed in that institution by the State Govt. and Right to establish its own Governing Body and to appoint its own staff and take necessary disciplinary action against the staff.


8. Library books as per norms & of relevant subjects shall be purchased before the start of the courses/classes.
9. Science labs as per guidelines shall be well arranged with Material, Chemicals equipment etc. before the start of the courses/classes.
10. The faculty required as per norms shall be recruited before the start of the courses/classes. (both teaching and non-teaching staff and as per affiliating university/UGC/State Government norms)
11. The separate building for the new college alongwith other existing run institutions shall be indicated on the land plan and submitted to this office before the start of the courses/classes, however, no institutions/college shall be running on the same premises where NOC has been granted.
12. The lab Material, Chemicals, equipment etc. must be arranged before the start of the courses/classes.
13. The Government can impose any other conditions (s) at any time which shall be binding on the College Management and also agrees to abide by any instructions issued by Government time to time.
14. The No Objection Certificate shall be on provisional basis for a period of two years. Permanent NOC shall be granted after watching the infrastructure, financial status and performance of the college for two years. A progress report in this regard shall be obtained from the concerned affiliating university and the college management as well.
15. In case the institute is not able to fund/sustain itself the Provisional NOC shall be withdrawn and the endowment fund submitted by the applicant shall be forfeited to continue the studies of the enrolled students, payment of salary of the staff and for other expenditures deemed fit. The FDR amount Rs. 50.00 lacs (Fifty lacs) are to be renewed from time to time.
16. Any contravention of the above stated conditions shall result in withdrawal of "No Objection Certificate" and legal action against the defaulting society/ institution including withdrawal of affiliation from the concerned University shall be applicable in all cases.
17. In addition to above, the general laws of the land relating to national interest, national security, social welfare, public order, morality, health, sanitation, taxation etc to applicable to all will equally apply to minority educational institution also. The instructions containing the general principles relating to establishment and administration of educational institutions by minorities issued by the National Commission for Minority educational institutions, Govt. of India, will be also applicable.
